CHEMICAL/FERTILIZER PROGRAM SECURITY AGREEMENT  Subject to the conditions set forth herein, Hazelnut Growers of Oregon ("HGO") agrees to advance the costs of chemicals and fertilizers as prepayment for the purchase of the Grower's hazelnut crop. Growers using the Chemical/Fertilizer Crop Prepayment Program agree that: (1) in consideration of Grower's execution of the Hazelnut Contract, Grower may, during the growing season, charge to HGO's account with suppliers designated by HGO the cost of chemicals and fertilizers obtained by Grower from such suppliers. Grower agrees that any chemicals or fertilizers charged to HGO's account shall be approved for use on and shall be used solely in the production of hazelnuts on the property described herein. Grower understands that HGO may instruct suppliers to require Grower to produce this agreement and proof of identity as a condition of such charges. The maximum allowable chemical and fertilizer payment in aggregate that HGO agrees to pay with the designated suppliers is \$500 per acre of hazelnuts Grower has contractually agreed to sell to HGO. Grower understands and agrees that when Grower delivers its hazelnut crop to HGO, the amount that HGO has prepaid Grower under the Chemical/Fertilizer Crop Prepayment program will be deducted from the amount otherwise owing to Grower for the delivery of Grower's crop 3). If Grower fails to deliver their hazelnut crop to HGO as agreed on or before October 31st, the non-delivery of the purchased product shall constitute a breach of contract. In the event of such breach, HGO shall attempt to resolve the breach with the Grower informally before resorting to legal action. In the event legal action is necessary to enforce this agreement or remedy a breach, the prevailing party shall be entitled to an award of their reasonable attorney fees and costs.
